WHEREAS, Mr. Derringer has made contributions to the State Teachers Retirement System of Ohio ("STRS") continuously throughout his service as an educator in Ohio, and is now eligible to receive STRS benefits based upon his prior service and contributions; and

WHEREAS, Ohio Revised Code Section 3307.35 permits an employee to initiate service retirement and to be reemployed; and

WHEREAS, this Board of Education wishes to retain the services of Mr. Derringer as Superintendent, and believes that retaining Mr. Derringer as Superintendent will be highly beneficial to the District by maintaining continuity of personnel, avoiding the costs and uncertainties of a new Superintendent search, and, most importantly, allowing the District to continue to benefit from the extensive knowledge, experience, and leadership abilities of Mr. Derringer.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION I

The Board of Education hereby accepts the resignation of Mr. Derringer, submitted for purposes of initiating earned retirement benefits, effective June 30, 2024.

SECTION II

The reemployment of Mr. Derringer is subject to all notice and public hearing requirements of Ohio Revised Code Section 3307.353. The Board of Education recognizes that, through its Treasurer, it gave public notice that Mr. Derringer will be retired and is seeking reemployment with the Tri-County North School District Board of Education not less than 60 days before May 6, 2024. This notice expressly stated that on April 15, 2024, at the regular meeting of the Board, the Board of Education shall hold a public meeting on the issue of the reemployment of Mr. Derringer. 


